#### Notes for SUSAN JANE GRAY:

The 2 children Thomas and Ellen listed in the household of Joseph and Mary on the 1860 census of Worth Co., Ga. are actually Susan Long's children. Susan was also listed as a Gray.

Ellen (Mary Ella) married James J. Noblin. See her death certificate and 1880 census in notes on Ella.

Susan also married a Mr Thomas (and had sons Jeff and Joe) and a Mr Allen. No Long-Thomas marriage found via Ancestry.com. Need to check Coffee County (burned Sep 1863). See Geneva County heritage book, pg 189, for article by Lavinia Jordan Helms in which she indicates that a Dooly County, Georgia, marriage record exists for Thomas Long and Lucy Smoke, 17 Sep 1873.

**1870 US Census:** not found in Geneva County, Al, or Dooly, Worth, Colquitt, Mitchell, Lee counties, Ga. No Longs, no Susan, Joseph, Marion or Jefferson Thomas on index to 1870 Geneva Co. census. None found in Alabama, Florida or Georgia via Ancestry.com indexing.

This 1880 entry is probably just west and possibly a little SW of Samson. Richard Rials patented land in S36 T2N R19E in 1885. His father's land was 2 sections north of him, obtained in 1858. Susan Gray's sons Thomas Long and Joseph M Thomas both patented land in 1892 just one section east of Richard Rials and adjacent the land of Jeptha Thomas, who received his patent in 1858. Wealthy Holley in 1895 got land that was 2 1/2 sections north of Thomas B Long and Joseph M Thomas. I have a document of unknown origin that claims Susan Jane Gray married Joseph J Thomas. In 1860, Jeptha Thomas had a son Thomas A, age 21, and a son Joseph M, age 19. However, Susan Gray was about 27 in 1860. Did she marry one of the sons or did Jeptha's wife, Barbara, die and he married Susan?)

Aaron Rials had most of the land in the E 1/2 of Sec 24 T2N R19E, near Pera (Elton?) and 2-3 mi W of Traveler's Rest Cemetery NW of Samson. Did Joseph & Mary move back from Dale Co (see 1880 census) to live with Susan? Is that why they are buried at Traveler's Rest and not near Leddon-Marl where his original land was? Are Susan and her husband also buried at Traveler's Rest? There is no stone for them there, but there are many, many unmarked graves. There is no stone for them at Eden Church, where Joe M Thomas is buried.
