

Descendants of William Holland

Generation No. 1

1. WILLIAM¹ HOLLAND was born Bet. 1780 - 1790¹, and died Bef. 23 Jul 1842^{2,3,4}. He married ELIZABETH UNKNOWN. She was born Abt. 1795 in Georgia⁵, and died Bet. 29 Feb 1848 - 07 Oct 1853⁶.

Notes for WILLIAM HOLLAND:

Relationships in this family NOT PROVEN! ONLY GUESSING - based on deeds and census reports.

In 1846, a William Holland appears on the Gadsden Tax List, paying tax on 1 male between 21 and 49. He may have turned 50 because in 1847 he was on the list but not taxed for any male between 21 and 49. He does not appear again after 1847 and he was not on the voter list of 1845. However, the Leon County voter list of 1845 at <http://ftp.rootsweb.com/pub/usgenweb/fl/leon/xmisc/1845votr.txt> does include a William Holland.

This person cannot be the same as the one in Gadsden, as he was apparently dead by the 1845 Leon tax roll when his wife appeared instead of him. Even if he had moved to Gadsden, he would have been at least 50 by 1840 and too old to pay the male poll tax in 1846.

He was probably dead by the time William, Jr. deeded Lot #4 Sect 23 T1N R2W to Elizabeth Holland on 23 July 1842 and certainly by the time she sold it on 6 Mar 1845.

Note: Elizabeth, William Jr, and Griffin W were the only Holland households in 1850 Leon County.

Is he father of Griffin W Holland (b. abt 1806)? - Not likely. G W was a doctor, large landowner and slaveholder, born in Virginia. Both William and William, Jr, signed deeds with their x mark.

Bk D, pg 578:3 Nov 1832. William Holland, the natural guardian of Jack Holland, do quitclaim all my claim and my son Jack's claim from the first day of 1836 to a certain tract of land unto John Lane of the same county and territory, until the said Jack Holland comes of age. . . for \$50 paid to me for said Jack Holland by said John Lane for lease of the following tract of land: East half of SE ¼ of Sect 24 T2N R1E containing 80 acres. . . for this time John Lane, his heirs, assigns, etc. shall pay the taxes of said land. Signed: William (his x mark) Holland.

Same page, just below:

29 Oct 1835. Tallahassee. Received of Adam Grambling one hundred dollars being in full for all my right title and claim to the within described land as witness my hand seal. Signed: John Lane
Wit: A J Fisher, Henry Williams.

Bk K, pg 64: 17 July 1849. Jack Holland to Adam Grambling, for \$200, the East ½ of the SE ¼ of Sect 24 T2N R1E containing 80 acrs. Signed Jack Holland. Wit: John R Crump, Margaret A Grambling.

Bk G, pg 21: 10 Aug 1839. William Holland, Jr., of Leon Co., to Joseph Reese of Leon Co., for \$125: SW ¼ of SW ¼ of Sec 25 T1N R2W containing 40 and 18/100 acres MOL. Signed: William (his x mark) Holland, Jr. and Sarah J Holland, his wife.

Also: I, Sarah J Holland, wife of William Holland, have granted . . . certain real estate to Elizabeth Holland the lot of land within named, for the sum of one dollar . . . and divers other good and valuable causes and considerations. Signed: Sarah J Holland. Same witnesses. (Note: does not indicate that either signed with "x" mark. On 1840 census, David W Owens was listed adjacent Elijah and Caroline Holland Bryan.)

Bk H, pg 443: 6 Mar 1845. Elizabeth Holland of Leon Co. to William Grimes, for \$100, 80 acres: lot #4 of Sect 23 T1N R2W according to the Certificate of the Receiver of Public Lands #8106. Signed her x mark. Wit: Franklin S Johnson and Lewis Grimes.

Bk K, pg 554: 7 Oct 1853. Roxa Anne Holland of Leon Co. to Isiah Johnson, Sr, for \$210. . . lot? upon which Mrs. Elizabeth Holland last resided. . . North ½ of Lot #5 of fractional Sect 23 T1N R2W containing 40 acres MOL, with the exception that one half acre square of said tract of land upon which the graves are now situated and are by the parties forever to be considered exempt reserved and - - -ated? from sale, and all sales? of the land above specified. . . to be considered as belonging to all persons severally who have deceased relations buried there and any of them interested shall at all times have the right of way to said graveyard. . . Signed: Roxa Anne Holland. Wit: Lionel Fletcher, Richard R Fletcher and Tom Holland.

No marriage record found for Mingel or Fillmore in Gadsden County. Indexed only by male. Scanned entire index to Book A, 1849-81. They both disappear after 1850.

Earliest existing Leon County tax roll is 1829 and there are no more until 1839, then 1843 forward.

1839 Leon County Tax Roll: Elijah Bryan 1 male 21-49, 40 acres, 1 slave

1843 Leon County Tax Roll: E Bryan 1m 21-49, no land, no slave

He does not appear again on a tax roll after 1843.

Gadsden County Tax Rolls:

1845: no Fillmore or Mingel

1846-1851: Alfred Fillmore 1 male 21-49, no land. After 1851, he no longer appears in Gadsden.

1846-1847: Henry Mangel (looks almost like Mangee on lists). 1846: 1 male 21-49, no land. 1847: no male, no land - does that mean he died that year? Does not appear after 1847.

1846 is the same year that William Holland appeared in Gadsden County. Any connection?

Difficult to determine exactly where in Gadsden Co. they were located. Surrounding entries seem to be in TWP 3 across northern county. This entry is between Gilchrists who had land in 3N 4W (north of Quincy) and Atwaters who were in 3N 6W (Chattahoochee).

There was a BLM land patent granted to Caroline Holland 7/28/1838 for 40 acres (Lot 5) in S23 1-N 2-W on the county line between Gadsden and Leon (lists in both counties), along the Ochlochonee River. In 1843, William Holland, Jr bought Lot 4 (adjoining?) in that same section.

Question: Who were William Holland Jr and Sr? Was one of them a brother to Caroline? - probably. Or to Griffin (William?) Holland of Leon Co.? - not likely. Was one of these Williams the one who was in Gadsden 1846-47? Not likely.

Not found as Fellman on 1850 census of Leon County. No Olivias listed in index at <http://www.rootsweb.com/~cenfiles/fl/leon/1850/>. Witnessed deed from Caroline in 1838.

Generation No. 2

2. WILLIAM² HOLLAND, JR. (*WILLIAM*¹) was born Abt. 1815 in Georgia¹⁵, and died 31 Aug 1859^{16,17}. He married SARAH JANE BARINEAU 02 Feb 1837 in Leon County, Florida¹⁸. She was born Abt. 1815 in South Carolina¹⁹.

Notes for WILLIAM HOLLAND, JR.:

William Holland married Sarah Jane Barineau in Leon County 2 Feb 1837, and they appear on the 1850 Leon Co. census, both age 35. He was also listed on the 1839 Leon County Tax Roll as William Holland, Jr.

S J Holland is listed on the 1860 Population Schedule as age 43, b. SC, a female planter with 6 children, 5 entries from Peter L Barineau (Barnow), 39, a farmer b. SC. Sarah J Holland appears on the 1860 Agricultural Schedule, 2 entries from Peter Barineau (Berneau). Apparently she is now a widow. (LDS IGI says he died 31 Aug 1859.) She is still there in 1870, two entries from Conyers (52) and Jane (49) Barineau, also from SC.

This William who married Sarah Jane Barineau does not seem likely to be the William who appears on Gadsden tax lists of 1846 and 1847 because he would have been assessed a tax as a male between 21 and 50 in both years, but the Gadsden William was not assessed such a tax in 1847 (implying he had reached age 50 and was exempt).

He appears to be the William Holland, Jr who received a land patent in 1843 for Lot 4 in the same section where Caroline Holland received a patent for Lot 5 in 1838. Those patents list in both Leon and Gadsden counties, as the land is right along the county line along the Ochlocknee River.

He is only about nine years younger than Griffin W Holland, whose middle name is reported to be William. Griffin bought 320 acres north of Lake Iamonia in Leon County between 1834 and 1838. G W Holland was a doctor and large landowner with many slaves. Both William Hollands signed their deeds with x's. They are unlikely to be from the same family.

1840: William, Jr not found on Leon census (only William the elder).
