1. C AUGUSTUS³ MURPHY (*WILSON*², *JOHN*¹)^{1,2} was born Oct 1836 in Pine Flat, Butler County, Alabama^{3,4}, and died 19 Apr 1909 in Pine Flat, Butler County, Alabama⁴. He married AMANDA F. WATTS 02 Feb 1855 in Butler County, Alabama⁵, daughter of JOHN WATTS and CATHERINE HILL. She was born 11 Apr 1834 in Alabama⁶, and died 02 Mar 1906⁶.

Butler County death records, age 73, of heart trouble. (Did county death records give Apr 19, 1909?)

Email dated 2 Oct 1998 from Rhonda McCrory to Linda Kuykendall re: Linda's FTM Murphy home page:

"I have papers that show that Augustus appeared on the rolls for the Confederate Army 45 Ala. Inf. Co. B for May 1863 to April 1864. He was employed as a carpenter. March 19, 1862 shows him on the company muster roll as a drummer for Capt. Flournoy's Company Unorganized Regiment of Infantry.

....My husband is descended from John A. McCrory, Sr and Annie Prudence Murphy who was born 8/31/1870, married 1/2/1890 (have Butler County Marriage Certificate), and died 5/19/1944 in Butler County Alabama. I have a picture of the headstone with John A McCrory & Annie M. showing John A (Oct. 21, 1864 - Nov. 15, 1935) and Annie M (Aug. 31, 1870 - May 19, 1944)...."

This CSR for Augustus Murphey (apparently being referenced above by Rhonda McCrory) does not appear to be for the Augustus from Butler County, for several reasons:

1. Age 29. Our Augustus would have been about 26 in 1862.
2. He enlisted in Opelika, a long way from Butler County.
3. Charles Murphey, possibly related to him, also enlisted same day in Opelika.
4. Augustus, son of Wilson Murphy, appeared on muster rolls of Goldsmith's Independent Company,

Alabama Volunteers (Butler County Militia/Home Guard) for 19 Dec and 30 Dec 1863, along with his brothers John and J B (Julius).

Compiled Service Record:

Augustus Murphey (sometimes spelled Murphy), drummer Co B, 45th Al, age 29. Enlisted 19 Mar 1862 in Opelika, Al by T F Flournoy. Undated pay receipt for Nov 1862 - 21 Apr 1863, 68.00, occupation: mechanic. Signed A Murphy.

Roll of non-com. officers and privates employed on extra duty during month of Mar 1864. Private, carpenter. Rolls of 28 May 1863 - 30 Sep 1863 and 1 Jan - 31 Mar 1864 repairing wagons for reg't.

Pay receipt 23 Dec 1863 as carpenter for 28 May - Sep 30, 4 mo 2 days, rate of pay 40 cents. Similar receipt for 30 Sep - 31 Dec 1863.

Charles Murphey, Co B, 45th Al, age 23 also enlisted 19 Mar 1862 at Opelika

Notes for AMANDA F. WATTS:

Sister to the Augustus Watts who married Augustus Murphy's sister Sally. Middle initial from marriage record. LDS entry at www.familysearch.org (contact Peggy Cooper) and some databases on www.worldconnect.rootsweb.com have her middle name as Allen.

Cemetery compilation that gives her birth/death dates has comment: "youngest sister of ex-Gov. Watts of Alabama, married Augustus Murphy Jan 30, 1855"

2. HORACE C.⁴ MURPHY (*C AUGUSTUS*³, *WILSON*², *JOHN*¹) was born 16 Dec 1855 in Alabama⁷, and died 03 Dec 1923⁷. He married MAUDE SHEBA CHEATHAM^{8,9} 28 May 1907 in Butler County, Alabama¹⁰, daughter of PETER CHEATHAM and NANCY MURPHY. She was born 02 Apr 1875^{11,12}, and died 08 Mar 1962¹².

Notes for HORACE C. MURPHY:

Butler County Marriage Records: H. C. Murphy married M. S. Boutwell on 28 May 1907. He is buried at Pine Flat with his wife. I visited this cemetery with Zula True, 10 Oct 1989. Made no notes on wife's tombstone, if there. According to compilation of local cemeteries, located in Butler Co. Probate office, her grave is unmarked. (Apparently, a stone has been placed since. See cemetery listing below.) That same compilation has: Fulton Underwood, son of Horace C and Maud S Murphy Sep 13, 1917 - Jul 30, 1926, also at Pine Flat.

Notes for AMBROSE MURPHY:

Buried at Pine Flat with wife, daughter Mary and wife's father, D P Price, in unmarked graves, according to a compilation of local cemeteries, located in Butler County Probate Office 1989. His name was pronounced Ambers.

AMBROSE MURPHY BITTEN BY SNAKE

On Wednesday afternoon of last week before dark, Mr. Ambrose MURPHY of Pine Flat was bitten by a rattlesnake in the hand. Mr. MURPHY was going through his plantation and had taken down a rail fence to let his horse through. As he was replacing the rails, he was bitten by a snake. He rode to the nearest neighbor's home and at once placed his hand in a bucket of kerosene oil. After a while the pain ceased, and Mr. Murphy was taken home in a buggy. Next morning the negroes on the Murphy place went to the place where Mr. Murphy was bitten and not twenty feet from it, they found and killed a monster rattlesnake which had 16 rattles and a button. At last accounts the sufferer was resting as well as could be expected.

I Recently found out that the above couple lived in Butler County. I'm interested in finding out any information I can about them.

My relation is through Ada, d/o Duke Preston Price (b. c. 1830, Henry Co., VA, lived in Butler Co., AL in 1880) and Mary "Mollie" Smith) I have a picture of Ada as a young girl, probably around 10 to 12 yrs. I also have a picture of her paternal grandfather Duke Price (1804-1891) taken around 1879.

Ambrose and Ada were married around 1880, as they are living as husband & wife in the 1880 census in Butler Springs. Ada is listed as 18yrs. They have no children at this time. Looking around the net and through contact with one descendant, I've found 4 of their children, Edward Preston Murphy, Mary Murphy (1895), Ada Murphy (1897), & Joseph Murphy (1900). There must have been other children between 1880 and 1895.

IN JAIL FOR TRYING TO GET A WIFE 5-13-1908 [Greenville Advocate or The Living Truth?]

Deputy Sheriff MURPHY gives us the following bit of court house news.

On Saturday the 2nd, a young man named Arthur SIMS, living in the Shackleville neighborhood, came to town and applied for license to marry Miss PHILLIPS. He swore that the young lady was 19 years of age. Upon making affidavit to that effect the license was granted. Next morning old Mr. PHILLIPS, armed with a shot gun, and bringing his daughter, came to town and went at once to the court house in search of Judge LAMPLEY. He wanted to know if it was a fact that young SIMS had secured license to marry his daughter, and Judge LAMPLEY told him he had, showing him the affidavit young SIMS had made. PHILLIPS then swore out a warrant for the young man, charging him with perjury, saying the girl was only fourteen years of age.

The warrant was turned over to Deputy MURPHY to serve. That afternoon he went out to make the arrest. When he got to the home of the girl, where he expected to find the young man, SIMS was not there. He then went to the young man's home but still failed to find him. He then gave the impression that he did

not want him anyway and left, but remained in the neighborhood, going back to SIMS home at 2 o'clock in the morning and found him still up and dressed.

SIMS told the deputy that if he would give him time to go and marry the girl, that he would give up and come to town with him. This proposition was agreed to and they went over to Mr. PHILLIPS' who then consented for his daughter to marry the young man. A minister was secured, Rev. Leander STINSON, and by the light of a pine knot, the words were said that made the two young people one. Mr. Murphy stood as best man, as well as guard. The officer of the law and the bridegroom, without the latter even so much as saluting his blushing bride, left for Greenville, reaching here at six o'clock Monday morning. The young man was placed in jail under the serious charge of perjury, where he still lingers. The Judge fixed his bond at \$300, which has not been made, and the disconsolate young man is pining in the gaol [sic], while the young bride grieves at the old homestead.

It is hard for this young man to be compelled to linger in jail just for telling a little "white lie" to get his sweetheart. Tens of thousands of other men do worse than that and never have to suffer. We hope the young man's friends will soon make the requisite bond.

The Greenville Advocate, Wednesday, April 24, 1895:

HORRIBLY MURDERED!

MR. WATTS MURPHY, OF BUTLER SPRINGS, FOULLY MURDERED BY NEGROES,
FIVE NEGROES - TWO MEN AND THREE WOMEN - LYNCHED
FOR THE CRIME

THEY CONFESSED THE DEED.

Last Saturday evening a rumor reached Greenville that Mr. Watts Murphy, the son of Mr. Augustus Murphy and the nephew of the late Governor T. H. Watts, was murdered by some of his hands while at work in his field. The news came so straight that Sheriff Barganier went down to the scene of the trouble and late Sunday evening from his son, Deputy Sheriff Barganier, we learned the following particulars:

Last Wednesday Watts Murphy was in his field with six negroes at work. He was sitting on a log, when the negro man, John Rattler, who was chopping sprouts with an axe, slipped up behind him and struck him with a heavy blow on the head. The negroes then took the body before death resulted and placed it between two logs and piled brush and logs on it and set the heap on fire. Murphy did not die until after all his hair had burned off his head.

Mr. Gus Murphy went over to see his son about an hour after the crime had been committed, and asked the negroes where he was. They told him he had mounted his mule and rode off. The fact was, one of the negroes, Zeb Colley, had tied the overcoat of the murdered man to the saddle and rode off some six or eight miles and turned the mule loose. A day or two afterwards the mule came back. The family began to search for the young man. The father, knowing that his son and some of the negroes working for him were not on the best terms and suspected foul play, had one of the negroes, Zeb Colley, arrested. Zeb then broke down and made a full confession, as stated above, telling all particulars of his horrible crime. He carried the grief stricken father to the scene, and there, smouldering in the log heap, were found the liver, heart and a few bones of the victim. These were gotten up and buried.

It was nearly dark Saturday evening when the Sheriff heard of the trouble. He went down to the scene and returned Sunday evening and from him we gathered the above particulars and also the following:

He stated when he arrived the negroes had been arrested and lynched and the posse had dispersed. He was told by Mr. Dunk Sirmon that he (Sirmon), together with Henry Clark, J. R. Sirmon, Jr., Frank Mize and others, had the negroes in charge and were on their way to jail with them. When within 10 miles of there, near the Buckaloo place on the old Federal Road, they were met by a posse of some fifty or more men who took the prisoners from them and hung them; the negro men on one tree and the negro women to the limbs of another nearby.

The negroes lynched were as follows: John Rattler, Zeb Colley, Martha Green, Alice Green, Mary Deen. The Sheriff failed to find any clue as to who composed the lynchers.

The cause of the trouble which led to the assassination is supposed to be that sometime last year Mr. Watts Murphy had a difficulty with a negro man, Jerry Dixon, whom he shot in the arm. Whether that has anything to do with it or is only a supposition, the cause may never be known.

This horrible assassination and lynching is a fearful blow to the reputation to our county, which was just recovering from the effects of the double lynching of Hipp and Kelley about a year ago.

Note from wrm: The Henry Clark mentioned in the article may have been the son of Susan Seale Clark who was daughter of Wilson Murphy's presumed sister Eleanor Murphy Seale.
