Jul 1909 in Butler County, Alabama<sup>6</sup>.

1860: Cannot identify Julius and Amanda definitely on 1860 census. This data for wife and children is way off. It doesn't look at all like Julius and Amanda, but neighbors in the Dawson area are the same people who appeared near them in 1850, 1870 and 1880:

There was another (?) J B Murphy in the same regiment as many other Butler Co. men, including Josiah Mullins, J A (John A?) Seale, James T Seale, William J Watts and Julius' brother R K (all in Co. F of 18th):

J B Murphy, Pvt, Co D, 18th Regt Al: paid 30 Apr 1863 by W B Hoyt, \$50.00 bounty. (No other information on him.)

### Notes for AMANDA E. SEALE:

Surname confirmed on death certificates of her son Augustus (Chuck) and daughter Sarah Elizabeth. In 1900, 93-year-old William Seale, brother to Anderson Seale, lived in the household of Amanda's son Augustus (Chuck) Murphy. His relationship was listed as "uncle". Anderson Seale, along with Amanda and Julius' brother Augustus, posted bond in Oct 1865 for her appointment as administrator of Julius' estate (Butler County Estate Book 10, pg 61).

I consider these facts confirmation that she was the daughter of Anderson Seale, who was brother to the Ransom Seale who married Wilson Murphy's presumed sister Ellen. Anderson Seale's household in 1830 included 2 females under 5 years old. Amanda was born about 1825. The other must have died, as she is not accounted for on later censuses. In 1840, there is only one female age 10-15, Amanda's age.

For a lengthy report of Seale genealogy, see: **Seale and Allied Families**, by Ida Carrie Seale, R.N., no date, but foreword to third edition is dated Feb 22, 1954 in Panama City, Florida. (As with all secondary sources, there are some inaccuracies, but it is a great starting point for leads.) Ida Carrie Seale had Amanda as the youngest daughter of Anderson Seale, married to "Wilson Murphy, who died in the Civil War." It was not Wilson who died in the war, but his son Julius. See notes on Amanda's son Augustus (Chuck) for incorrect information on his death certificate which may have given rise to the idea that Amanda married Wilson. Ida Carrie also had Amanda's birth year incorrectly as 1841. Some reports have merged Amanda with her sister Melissa, born abt 1841.

Birthdate from 1900 US Census. She lived with son Anderson D. (Doc). On 1850 Census, age is given as 21 (Butler County TWP 7, #175). Death date approximate; stricken from Civil War Pension Register (in Butler probate office) July 1909, as deceased.

Annie Belle Murphy Phillips, granddaughter of John W, remembered that his mother was named Mandy and said she was a midwife. (Note: **Butler County Register of Births 1894-1899** in the Probate Office lists the name Susan Coleman (John's sister) as midwife in many births. Was Annie Belle confusing Mandy and Susan, or was Mandy also a midwife?)

There are 4 unmarked adult slabs in Shackleville Cemetery near the graves of John, Effie and Bill Murphy and another next to Emmett's daughter Lucy. I was told that Amanda, Bett and Bett's sons Zoll and Hill Murphy are buried there without markers.

**Confederate Pension Applications** dated 4 July 1887 - 9 June 1899 for Amanda E Murphy, widow of Julius B Murphy, private, Co E, 12th Ala. Regt. The application of 21 Apr 1896 stated that her address was Shackleville and her taxable property consisted of 29 (or 27?) acres of land. The application of 21 May 1897 stated that her address was still Shackleville, but her taxable property consisted of "nothing". (Did she deed the land to one of her children?)

The application of 9 June 1899 included a schedule of property:

Real Estate: "no" acres of land, value: \$50 (meaning?)

Horses and Mules: none; Cattle of all kinds: "one", value: \$10

Hogs, sheep and goats: "none"; Pistols, guns, etc: "none"

Watches, clocks & jewelry: "none"

Household and kitchen furniture: "none; Burned with house"

Bicycles and vehicles: "none"; Goods, wares and merchandise: "none"

Mechanical and farming tools and implements: "none"

On 9 and 10 June 1899, Augustus Murphey and T M McCrory attested to acquaintance with Julius Murphey and to personal knowledge that he served in CSA and did not desert.

## Notes for JULIA E. (JUDY) MURPHY:

Age 19 on 1870 census (July) in home of Amanda. Why was she listed in her mother's house, when she had been married in March of 1870? Marriage record: married "at Mrs Murphy's". Listed as Julia E. Sims, wife of Nathaniel Sims, in final list of Julius' heirs, 25 Jul 1870.

She and Nathaniel may have moved to Indian Territory. Sims researchers report that Isaac Sims' estate papers (1888?) list a Nathaniel Sims (reportedly born about 1850) as resident of Indian Territory.

Julia may have died by 1900. On the census entry for her mother, Amanda, it said 7 children were living, of 8 born. All the others except Julia are accounted for.

### Notes for NATHANIEL A. SIMS:

1850 - (from Sims researcher Cheryll Sumner): Butler Co. Deed Book B, pg 440-441 (abstract) James Marion Sims bought land from Wilson and Anna Murphy in 1850 -- East 1/2 of NW 1/4 Sec 33 T10 R12, 80 acres for \$1500 upon which Butler Springs are situated, also 12 acres in west 1/2 of NE 1/4 in same section, TWP and range near Murphy's Creek... (note from WRM: BLM document #36677 shows Wilson Murphy received patent on that land on 3 May 1848.)

History of Butler County, Alabama 1815 to 1885 by John Buckner Little, pg 137-138, regarding Butler Springs:

John Ubanks built a temporary tavern here in the spring of 1843, and had the Springs thoroughly advertised throughout the surrounding country... The Springs were purchased the next year by Nat. Sims, a wealthy farmer from Lowndes County, who soon erected a fine hotel... After the death of Nat. Sims in 1855, his widow sold the Springs to John Edy, who kept them only a few years and sold them to Captain T A Knight and Alph. Carter, 1860. (Note from WRM: Little report conflicts with documented BLM patent in 1848 and sale in 1850, above.)

**2.** SUSAN M.<sup>4</sup> MURPHY (*JULIUS B.*<sup>3</sup>, *WILSON*<sup>2</sup>, *JOHN*<sup>1</sup>) was born Abt. 1846 in Butler County, Alabama<sup>10</sup>. She married JOHN COLEMAN 11 Dec 1873 in Butler County, Alabama<sup>11</sup>. He was born Abt. 1800 in Georgia<sup>12</sup>.

#### Notes for SUSAN M. MURPHY:

Age 4 on 1850 census. Age 21 on 1870 census. One source said she was buried in unmarked grave at Shackleville Cemetery, but Susan moved to Florala with daughter Nellie Coleman Patricks, and descendant Zula True thinks she is buried at Greenwood in Florala, unmarked grave. Nickname was 'Puss'.

On the Butler County Register of Births 1894-1899, the name Susan Coleman appears many times in the column marked "Doctor, midwife or head of family". Apparently she was a midwife.

There is a Butler County marriage record for a Susan Murphy and John Yeldell at Monterey, 23 Dec 1870, but I don't know if our Susan ever married anyone before John Coleman. Her sister Bett apparently married a Thompson but kept using the name Murphy. Zula True's family sheet has a note that Sophie's father was Yeldell, but no documentation is cited. Susan was listed as Susan Murphy on the final settlement of Julius' estate, 19 Jan 1872.

1880 US Census, Butler County, Beat 1, Starlington, no #:

1900 US Census: see daughter Nellie Coleman Patrick notes; Susan's age was 51, birthdate May 1849.

1910: not found in Alabama via Ancestry.com indexing. Scanned all 83 pages of Florala precinct 9 where Ella Murphy Dixon, Ola Coleman and Nellie Coleman Patrick lived. No Susan found.

Alabama Death Index has a Mrs Coleman, died 9 Apr 1922 in Covington County, Vol 13, Role 2, Page #6364. Unknown if this is Susan. No certificate # given. It could be some other Coleman's wife.

## Notes for JOHN COLEMAN:

Age 80 on 1880 census Butler County, Starlington, Beat #1. Reported by Zula True to be buried at Greenwood Cemetery in Florala, but on her family sheet, she has that he died in Providence, Butler County. Needs further research.

Death certificate says she died of paralysis at 1 PM. Obvious error on certificate in that certifying physician said he last attended deceased on July 6. Certificate filed June 10. Reported age 73 does not match with reported birthdate of 25 Aug 1849. If 1849 were correct, she would not have been 73 until Aug 1922. She was reportedly already 2 years old on 1850 census which was taken in December. It seems more likely that her correct year of birth was 1848, except that probate records of estate of J.B. Murphy, 25 July 1870 stated that Elizabeth was under 21. If she had been born in 1849, she would not have been 21 until August of 1870.

Death certificate confirmed parents as J B Murphy and Amanda Seale, both born in Alabama. No address given, just Registration District No. 15, but doctor's address was Bolling, Al, a little southeast of Georgiana. Informant was J Murphy, probably her brother John W, or possibly her son Jim, but he lived near Florala. Reported buried at Shackleville on 8 May 1922.

Age 2 on 1850 census. Age 20 in 1870. Listed as Sarah E in estate papers. No headstone on grave.

Information on Bett's children and their spouses was provided by James Earl Murphy and Jessie May Murphy Godwin, Emmett's children, in phone conversation Nov 1985. Ages and order of birth not given, except that Emmett was the oldest.

Bett may have married a Thompson, and Emmett's name may have been Thompson, although he used the name Murphy.

She was born 1851<sup>25</sup>, and died 07 Jan 1937 in Butler County, Alabama<sup>25,26,27</sup>.

### Notes for JOHN WILLIAM MURPHY:

Dates from tombstone. Age 19 on marriage license (Effie was 20). Married at Jack Lee's. License included authorization for license for her son, signed by Amanda E Murphy. I have a copy.

Shot by nephew Emmett over land line dispute. Name was listed as James on 1870 census in home of Amanda. John W was a good musician, a fiddle player, according to granddaughter Annie Belle Murphy Phillips, 1985. His sons Pete and Pode were also good musicians, as were his grandson Lewis Palmer and his nephew Emmett.

Alabama Death Index, 1908-59 has entry for J. W. Murphy died Jan 1929 in Butler County, Vol 1, Role 3, Page 241.

(Death certificate of Chuck's sister Ella gave her father's name as John Murphy!) This death certificate information may be the reason Ida Carrie Seale thought Amanda married Wilson. Mother's maiden name given as "Mandy Seale". Informant was S T Williamson. (Middle initial difficult to interpret. Looks like T, but could be I. Annie Belle listed Chuck's sons Tom, Babe and Sullivan and daughters Minnie and Pearl. He married GEORGIA TAYLOR 29 Oct 1889 in Butler County, Alabama<sup>54</sup>. She was born 1867<sup>55,56</sup>, and died Aft. 1919.

## Notes for Anderson D. (DOC) MURPHY:

Death certificate does not provide much useful information. No information on parents or spouse. No birthdate, no age, no name of informant. All it has is date of death, of organic heart disease, at home in Jones Mill; occupation blurred - clark? in "mdse"; born in Butler County; buried at Mt. Pisgue(sic), signed W A Mason, MD, Excel, Alabama.

Age 11 on 1870 census. Butler County marriage record: "married at home of William Taylor". Assume all children born in Butler County, but Annie Lou may have been born in Monroe. Both James Earl Murphy and Annie Murphy Raines (children of Emmett) reported that Doc lived in Excel, Ala. Annie Belle Murphy Phillips listed his children as Ola May, Annie Lou, Zema and another boy. Said Chuck and Doc both lived in Excel and both had stores.

You know I always heard "Ora Mae." But, as a child, I could have easily mis-heard. I really think it was Ora Mae. The census takers often wrote what they heard which can be confusing.

A story for you...I remember attending Ora Mae's husband's funeral. Lige was murdered in Atmore, Al., at his bar-restaurant. It was an awful experience for a child to see that grieving family. The daughters Pauline and Dorothy actually wailed with their mother. The services were held in a church in Excel and I remember I walked down the line with my parents, shaking everyone's hand. I was so frightened by the experience that when I took Pauline's hand, I said "I am so glad I could come." Then, later was mortified because I knew that wasn't the right thing to say.

Lige had a huge skating rink and a swimming pool in Monroeville when I was little. I can still remember the fun we had in the pool. Dad like to go swimming at night and we would spend a couple of hours there. The bright different colored lights that were strung around the pool, the smell of chlorine and the fear of the high dive are still with me! I remember spending the night at their house when my sister was born. Ora Mae had milk cows and delivered me and our milk back to our house the next morning. Lovely memories.

I didn't know that my cousin Ora Mae Murphy Williamson was related to your Murphys until tonight when I checked for sources. She married Elijah Williamson, called "Lige." Ora Mae and Annie Lou are sisters. The Williamsons were very close to the Sims family, so it just makes sense that Doc Murphy's daughter, and Ora Mae's sister, married Sherrod Sims. I will try to get some documentation though.

He was born Bet. 1854 - 1855<sup>70,71,72</sup>, and died 22 Dec 1939 in Florala, Covington County, Alabama.

Notes for Ella Annie Murphy:

Death certif. gives birthdate as Dec. 19, 1862. Was name actually Eleanor Ann?

Butler County marriage records: Mrs. Annie Murphy married W.H. Dixson on 20 Oct. 1904 at Georgiana by W J Powers, minister of gospel. W H Dixson signed his name with 'x'. Estate papers of her father, Julius Murphy, mention Annie as youngest of his heirs.

**Butler County Register of Births, 1899 -** (no end date) (in Butler County Probate office) lists illegitimate male child born to Ella Murphy, Beat 18, Jan 25, 1900, reported by Henry Green. Census 1900 lists son Hamp as 2 mo. old, born Mar? or May? 1900.

-----

Funeral record provided by Evans Funeral Home in Florala states that Ella is buried in Greenwood Cemetery, Florala, Ala, lot #1, grave #1. The undertaker listed on the death certificate was Shepherd Funeral Home of Florala (a precursor to Evans?). She died at 3:30 PM, Dec 23, 1935 of valvular heart disease, at home, Railroad Ave and Florala Ave. The certifying doctor was from Lakewood, Fla. (The Jackson logging camp where Hamp worked was near Lakewood.) The funeral, ordered by Mrs. Charlie Collins, was charged to Brown Service Funeral Co, in Florala. It was secured "by policy". She was a Baptist. Services were held at 2 PM on Christmas Eve at home of Hamp Murphy in Florala.

Her personal information was taken directly from the death certificate, the informant of which was her son Hamp Murphy. Her father's name was listed as John (not Julius) Murphy. (Julius had been dead for 70 years, and apparently no one knew of him.) Mother's maiden name and birthplace were listed as unknown.

Lizzie's daughter Dorothy Applin told me (in a telephone conversation in the mid 1980s) there was no tombstone for Ella.

-----

On the 1900 census, several of the ages and Hamp's birth date were clearly changed on the census entry. They were written in over the original numbers in a darker pencil at a later time, apparently to make the ages agree with the date written. George's age of 13 was written in over something else; Buna's age of 7 was written over an '8'; Lizzie's age of 5 was written in over a '6' and Hamp's age of 2/12 was written over something else; the '9' in 1900 was written over an '8'; the last letter of the month was very faded and could have been 'r' instead of 'y'.

The Ancestry.com copy is almost illegible. I took this information in the 1980s from a microfilm copy.
