1. WILSON² MURPHY (*JOHN*¹)^{1,2} was born Abt. 1801 in Georgia^{3,4}, and died 28 Jul 1878 in Butler County, Alabama⁵. He married ANNE UNKNOWN. She was born Abt. 1803 in South Carolina⁶, and died Bet. June 1860 and 03 May 1861^{7,8}.

Butler County, Alabama Obituaries by Marilyn Davis Barefield, 1985, pg 70:

Wilson Murphy, 78, died at his home in Butler Co. 28th of July 1878; was a native of Ga; emigrated to Alabama at the age of 14 when Butler Co. was still in the hands of Indians. He was near the spot when Col Butler was killed by the Indians and he pointed out his grave 44 years later when citizens decided to give him a more decent burial. He was survived by five children. Greenville Advocate of 8/8/1878

Butler County Alabama Obituaries compiled by Marilyn Davis Barefield 1985, p. 70 and The Greenville Advocate, Vol. XIII, Number 39 Greenville, Butler County, Alabama, Thursday. August 8, 1878. 'Died at his home in Butler county, on the 28th of July last, Mr. Wilson Murphy, in his 78th year. Mr. Murphy was a native of Georgia, but emigrated *with his father* to this State and county when but 14 years of age, when Butler county was still in the hands of the Indians. He was near the spot when Col. Butler (the hero for whom this county was named,) was killed by the Indians, and he it was who pointed out the grave forty four years afterwards when the citizens determined to give his bones more decent burial, by bringing them to Greenville. "Mr. Murphy was a member of no church; he lived and died in the belief of final holiness. He leaves five children, all having families of their own, to mourn his loss." (Quote marks as in Byron Murphey's source list.)

Note: "in his 78th year" means that he had not completed his 78th year, at the end of which he would be 78 years old. We are not 2 years old in our second year, but at the end of the second year. So Wilson was 77 when he died. If he had already had his birthday by the time he died on 28 July, it would place his birth year in 1801, consistent with all census records, most of which were supposed to be as of 1 June. His age was consistently 1 year short of the census year. However, if he died before he had reached his 78th birthday later in the year, it would place his birth year in 1800.

Wilson had a very close relationship to John Murphy (d. 1844) and, since Wilson's obituary stated that he emigrated with his father from Georgia to Butler County, John was almost certainly his father. From Wilson's estate papers, sale of lands, Estate Book 16 pg 220: His 480-acre home place at Pine Flat included half of the SE 1/4 of Section 21 T10N R12E, for which John Murphy had received a patent in 1835 (BLM doc #16672). See notes on John's wife, Sarah, for other evidence.

Alabama Records, vol 243, Butler County, compiled by Pauline Jones Gandrud, pg 2:

"Lawsuits to State Supreme Court" June Term, 1844. The State versus Murphy. On points referred by Circuit Court of Butler.

Indictment charges that the defendant, with other persons, did on 4 Feb 1843 conspire wicked maliciously etc. to seduce from her virtue, one Temperance Buckalaw, a young maiden lady; and to assist and enable John Henry Watts to effect a pretended marriage with said Temperance Buckalow and to make John Buckalow and Temperance Buckalow, Sen. (Father and Mother of said Temperance) believe it to be legal; and thereby to enable said John Henry Watts carnally to know

her, without legal matrimony between them.

Indictment further charges that J H Watts, Wilson Murphy and the other conspirators afterwards on 24 Mar 1843 repaired to the house of the father and mother and falsely represented to them and their daughter, that said J H Watts had obtained a license from Clerk of County Court of Butler, giving authority to anyone legally authorized to celebrate rites of matrimony to marry them. That Sterling B Parker (one of conspirators) represented himself to being a JP of Butler Co.; and he did then and there unlawfully marry J H Watts and Temperance Buckalow. The said John Henry Watts then and there, pretending to be the lawful husband of said Temperance, went to bed with her, etc...

Was he the same John Henry Watts who was married to Ransom Seale's daughter Amelia and died in 1850? Probably not, as a descendant of Temperance Buckaloo reported that J H Watts went on to marry Temperance for real and they had a son in 1850.

Wilson Murphy: 1 male 30-40 (Wilson), 1 female 20-30 (Anne? - she would have been abt 37)

2 males under 5 (Augustus and James), 2 Males 10-15 (Julius and John)

1 female 5-10 (Sarah) plus 9 slaves

(Ransom Seale is adjacent entry)

Note: Is this the same wife as in 1830 and 1850? Does not fit either one, unless she was on the borderline of abt 20 in 1830 and abt 30 in 1840. Too young to be same as Ann in 1850 and 1860. Was the stroke in the wrong age bracket on this census?

1850 Slave Schedule, Butler County, Alabama, Beat 3, 25 Sep:

Wilson Murphy: 45 slaves (John Murphy had 50 slaves in 1840; since Wilson had only 9 slaves in 1840, it appears that he picked up a large number of them when John died.)

1850 - Butler Co. Deed Book B, pg 440-441 (abstract) James Marion Sims bought land from Wilson and Anna (her x mark) Murphy in 1850 -- East 1/2 of NW 1/4 Sec 33 T10 R12, 80 acres for \$1500 upon which Butler Springs are situated, also 12 acres in west 1/2 of NE 1/4 in same section, TWP and range near Murphy's Creek... (note from wrm: BLM document #36677 shows Wilson Murphy received patent on that land on 3 May 1848.)

Butler County Deed Book J, pg 351:

3 May 1861. Deed from Wilson Murphey to officers of Ebenezer Baptist church for lot of land on which to build a house of worship. Signed: Wilson Murphey. Wit: Ransom Seale and Seaborne Moore. (Note: *No signature of Ann Murphy on this deed*. Assume she was dead by then.)

Note: In *1860 Monroe County*, there was a large landowner named Rufus K George, age 63, from Ga - farm value \$12000, personal property=\$97000 (Vincent Watts was his overseer) - any connection with Wilson and Ann? Namesake of all their descendants named Rufus King? Also, on Butler Co. 1870 census #260, there was a black farm laborer named Adeline George listed with John Clark and wife Susan, who was daughter of Ransom and Ellen Murphy Seale. From **Butler County in the Nineteenth Century** by Marilyn Davis Hahn, 1878, page 170: Real estate taxes for 1856, Precinct 11: Alfred Carter for Rufus K George. George connection needs further research.

1866 Alabama Census Butler County, Alabama: only Wilson Jr is listed.
