Card header **S K Powel**, in Gant's Co, 40<sup>th</sup> Reg't: Register of Claims of Deceased Officers and Soldiers: By whom presented: **Mary J Powell**, W; filed 3 Aug 1863; died at Vixburg (sic), Miss. At bottom of card: Confed. Arch. Chap 10, File No. 30, pg 165. No further information.

There was also a file for **Green J Powell**, Co. I, enlisted at Mobile, 10 May 1862. (George B J Powell had a son Green J, age 11, on 1850 Dale Co census. GBJ moved to Covington by 1860.) pg 213: **Powell, John T**: Dothan, RFD 6, born 12 Oct 1835 at Dublin, Lawrence Co, Ga; enlisted at Monticello, Al, in July 1862 as Pvt, Co B, 2<sup>nd</sup> Al Reg't and continued about 2 weeks when assigned to hospital about 1 Aug 1862 and remained until close of war.

# **Confederate Pension Applications**

**H M Coon**, wife **Mary (Powell)**, Covington County (Hartwell Marion, from ADAH service card) His application approved 16 July 1900. Private Co A, 33<sup>rd</sup> Regt. Enlisted 10 Mar 1862 at Mt Ider. Discharged in Spring 1865. Age 67. PO Green Bay. Signed H M Coon. D N Jordon and E Lindsey (signed his x mark 30 May 1900) attested to his Confederate service on 26 May 1900.

Part of his record is erroneously grouped in with the file of the widow of Cary Coon:
On Mary's application of 7 Feb 1914 to be placed on the pension roll: He died 17 Nov 1913 and was on the Covington pension roll. Mary signed her x mark. W D Powell and Mrs J A Powell of Covington County attested that she had not remarried (I, J A Powell, a resident of Covington... W D Powell is William D, Hartwell's -- and possibly Mary's - - nephew, son of Mary Jane Coon and Samuel Richard Powell. J A is probably Judie A, W D's wife. In 1910, W D and Judie Powell lived 5 entries away from Hartwell and Mary Coon in Green Bay.)

Mary's application of 3 Jan 1916 to be placed on second class pension roll: current pension #11877; her age approximately 78; says they married in Dec 1858. T D Coon (with his x mark) attested to marriage prior to Apr 1865. Witnesses: C W M? Morgan? and W D Powell. She signed her x mark. Application filed in office of Probate Judge on 8 Feb 1916. (See pension application of Mary Jane Coon Powell, widow of Samuel Richard Powell, signed on same day, 3 Jan 1916, with same witnesses.)

**J M Coon**, b. Coffee County. **W D Powell** on 13 July 1911, attested that J M Coon was over 70 years of age, having known him for 40 years. Statement on 12 Jan 1915 that he was born in Elba, Coffee County, Alabama. **W J Stanley, Sr**, on 22 Jan 1915 attested that J M Coon was over 80 years of age, having known him 70 years. Coon enlisted in 53<sup>rd</sup> Ala on 12 Aug 1862 at Elba. Wounded at battle of Tuscumbia, injured "being throwed from a horse." Age 64, PO Halton, Coffee County. (No date on this page of the application. Schedule of property was signed 13 May 1899 before Henry King, JP in Coffee County, but application was for Covington County. Henry G Neal attested (with his x mark) to J M Coon's Confed. service. Kenard Meeks also attested (Coffee Co). (Note: William D Powell was son of Samuel R Powell and Mary Jane Coon, sister of Hartwell. 1910 census Covington County, Green Bay: William D Powell, age 50 (Al Unk Ga), farmer, rents. Wife: Judia A, age 50; 4 children at home. Son Arthur B Powell, 21, adjacent.)

2 Jan 1922. Application of **Lucy Ann Coon**, widow of J M Coon, who died 4 Nov 1922 at Opp, Covington County; his pension #2426. PO Opp. Married 14 Feb 1861 near Elba, Coffee Co. She was born near Elba on 14 Feb 1847. Now aged 75 yrs 11 months. Lives alone. List of children:

**Lewis J Coon**, Co F, 3<sup>rd</sup> Alabama, application of wife Jane, Coffee County. Signed her x mark to application of 13 July 1887. On 28 Apr 1899, J G Jones attested with his x mark to the Confed. service of Louis J Coon.

**T D Coon**, Co I, 40<sup>th</sup> Alabama, wife Eliza A, Covington. She signed her x mark on 2 Apr 1920. He died 5 Mar 1920, on pension roll of Covington County. (Pension #2424) Full name **Eliza Ann Margaret Coon**, PO Opp. Currently lives with G M Terrell. She was born in Columbus, Ga, 12 Mar 1848. Her father was **William Holloway**, d. 1866 in Crenshaw County, Alabama.. Her husband's name was **Thomas Dulane Coon** (name was typed and clear). (A Worldconnect database calls him Thomas Danley Coon.) Married 6 Jan 1866 in Crenshaw

County, Alabama. He died 4 (conflict with earlier page) Mar 1920, Rt A, Opp, Alabama. She moved to Alabama about 1855. Thought her husband had been imprisoned in Illinois until 21 June 1865. She signed property inventory on 12 May 1928 (very labored handwriting).

On another application, her birthdate was given as 12 Mar 1847. She was living with **B F Martin**. Said her father had died in Covington County (no date) and she married in Covington County in 1866. Name typed in as Elizar A Coon. Husband was captured in Tennessee in 1864 and imprisoned at Rock Island, Illinois. Signed her x mark to property inventory 29 Nov 1920 before **W D Powell**, "a Jestis of the Pease", Covington County.

Application of T D Coon 26 Jan 1915. Age over 70 attested by **W D Powell** and **J M Coon**. Appl of 7 Jul 1911 said T D Coon was born in Georgia, but on 29 Sep 1914, said he was born in Elba. Signed his x mark 7 Jul 1911. John S W Cawthon, having known him 25 years, attested to his age over 70. On 17 July 1902, Hyram Gantt attested to his Confed service. Also William Jordan attested. (Note: on CSR of Samuel R Powell, husband of Mary Jane Coon, Co I of the 40<sup>th</sup> was referred to as "Gant's Co." Hiram Gantt lived adjacent N B Powell in 1860 Covington County.)

**Abraham Powell**, Co C, 15<sup>th</sup> Ala, Dale County, widow Malinda Powell. Property inventory signed 16 Jul 1902 (her x mark) as Malinda Mosley Powell (the Mosley scratched out) before H J Mosley, NP. Application says he was in Co E (file card header says Co C). A H Auston and W J Pouncey attested to his Confed. service on 14 Jul 1902.

**A R Powell**, Houston County, Private in 54<sup>th</sup> Alabama, enlisted at Pollard 6 Aug 1864. PO Dothan. 55 years old. Signed x mark 16 Apr 1901.

**A R Powell**, Dale County, Mrs **Martha D Powell**, widow. Signed her x mark 30 July 1889. On 20 Jan 1916, she was 76 years old. Married 11 Nov 1852. D J Powell witness to her statement. He was private in Co C, 31<sup>st</sup> Georgia Regt.

**B F Powell**, Co C, 59<sup>th</sup> Alabama, Coffee County. Also referred to (and signed on 26 June 1901) as B L Powell. Enlisted 5 May 1862 at Louisville. Age 64 at time of app. W G Thompson and William Anderson attested to his service on 26 Jun 1901. All signed before A S Helms, NP. Benjamin, son of Abraham and Lithie.

**C P Powell**, Co A, 57<sup>th</sup> Ala. Pike County. Mrs. **E S J Powell**. He died 1884. Signed her x mark on 13 Oct 1903. J P Wood and T M Murphree attested to his service. No further info. Cure P & Elizabeth S J Dowd.

**George B Powell**, Covington & Coffee, Co I, 29<sup>th</sup> Ala. Mrs **F M Powell**. He died during war. Signed her x mark 20 July 1887(?), Coffee County. Not found on census 1880 or 1900 Coffee or Covington.

**H C Powell**, Co I, 15<sup>th</sup> Ala, Pike County. (Hansford, son of Richard and Charlotte) Widow Martha Jane **Powell**. PO Troy. He died Sep 1905. He enlisted 1 July 1862 at Troy. Served with Col. Perry and Capt Ike Parks. Wounded 7 Oct 1864 at battle below Richmond near battle of Seven Pines. J C Hill and A C Worthy attested to her widowhood on 18 Jan 1912. Lives with her sister, PO Troy. She was b. 5 Aug 1845 at Troy, Alabama. One appl. was 6 Sep 1912. Her father was **William Faulk**, died in Civil War.

Her husband was **Randall Ammons**, married Nov 1865 in Troy. He died 19 Aug 1871 in Troy. She married **H C Powell** Jan 1880 in Troy. One of his own apps. was signed 7 May 1898 (others from 1887-1897). Wounded in left lung and shoulder at Darbytown Road, Va, 7 Oct 1864. Farmer. No taxable property. Enlisted in Sep 1861 at Troy. W S Coleman and J D Jones attested to his service on 25 Apr 1899.

She owned one 2-room house and lot about 2 miles north of Troy on side of ACLRR. Inventory signed 19 Nov 1920.

Henry J Powell, Geneva County, Co E, 15<sup>th</sup> Ala, widow Nancy Ann Powell, RFD 2, Samson, Alabama. . He died 1 Aug 1890. Signed her x mark to appl on 11 Jul 1911. Note 11 Jul 1911 from Dr B J Lewis that "Mrs Nancy Ann Powell is mentally unqualified to answer any questions intelligently and is very old and feeble." W R Painter attested to his Confed service 13 Jul 1911. 15 July 1911 letter from R L Justice, MD, that she was age 72 and unable to work on account of insanity and mental abberation. Letter from pension board on 26 June 1914 stated that she was ineligible because name Henry J Powell not found on rolls of Co E, 15<sup>th</sup> Alabama. (The only Nancy Powell indexed by Ancestry.com in Geneva Co 1900 was in Samson, b. 1840, wife of T J, b. 1850 in MS.)

**J M Powell**, on pension roll of Covington County, over 70 years old, born in Barbour County. No one in this part of the country who can testify as to his birth. Signed affidavit of his birth on 16 Nov 1912. W F Martin, having known him for 52 years, attested to belief that J M Powell was over 70 years. (Note: Eliza Ann Holloway Coon, widow of T D, was living with a B F Martin abt 1920. See her pension notes above.) Enlisted in Co B, 18<sup>th</sup> Ala, in Andalusia on 22 July 1861. Wounded at battle of Kennesaw Mtn, Ga. Property inventory signed on 9 Jul 1904. J E Hughs and W F Martin, 1<sup>st</sup> Lt Co B, 15<sup>th</sup> Al Vol, attested to his service in July 1904.

**Jacob Powell**, Co E, 59<sup>th</sup> Ala, Geneva County. Enlisted "in the first part of 1862" at Skipperville. Was not wounded. Age 76, PO Hartford, at time of app. Signed his x mark 2 Aug 1907. Discharged from Federal Prison at Rock Island, Il on 17 Jun 1865.

**John Powell**, Pvt Co D (or G), 7<sup>th</sup> Miss. Reg't. Petitioner Margaret L Powell, Coffee and Crenshaw counties. Appl signed by x mark 25 Apr 1891 and 17 May 1892 in Pike County and 5 Apr 1894 in Crenshaw County. PO Luverne in 1898. PO Brantley in 1896. Drawing pension in Clarke County 1916, over 100 yrs old, married prior to 1861. T J Powell, in Coffee County, attested to John Powell's Confed. service on 14 Apr 1897. Mary Ann Ward (x mark), in Covington County, attested to his service on 9 Jun 1899. Monroe County also involved. (From file of Samuel R Powell/Mrs. M J Powell: Affidavit for Margaret L Powell on 10 Apr 1908 that she was 103 years old. Same person? Unknown why her item was in other Powell file.)

John Powell. Widow Mary L Powell of Covington County. Appl rejected 17 Oct 1913. No proof of service.

**John A Powell**, Co K, 5<sup>th</sup> Ala. Widow Eliza Ann Powell. He died 29 Nov 1902. Signed her x mark to appl on 1 Jun 1903. Levi Davis and R R Alford attested to his service same day. She lives at home with her daughter, Samson, Rt A. Born 22 May 1844 in Coffee County. Father was Assie (Asie) Bally (Baily), who died in Coffee County (no date). Married John A Powell 15 Feb 1865 in Coffee County. He died in Geneva County 29 Nov 1902. He enlisted at Old Town, Coffee County; Col Hall and Capt Gilchrist. Captured in "Merrilen" 9 Apr 1865. Property inventory of 25 Nov 1920: Owns 120 acres in Geneva County, value \$1000. One 4-room house. 35 acres of land in cultivation. (Probably son of Isaac and Mary.)

**K P Powell**, Co I, 15<sup>th</sup> Ala. Pike County. Born at Troy in Pike County, 1 Mar 1837. Joseph Bell, having known him for 64 years, attested to belief that he was over 80 years old on 9 Apr 1917. Enlisted 4 Jul 1861 at Fort Mitchell. W S Coleman and J R Boone attested to his service on 16 Mar 1899. Shot in the right shoulder and through the face on 7 Oct 1864 at New Market Heights in Va. He is a farmer. On 8 Jun 1897, taxable property consists of two mules. (Kinion Pierce Powell - see 1907 Census of Confed. Veterans.)

**Larkin W Powell**, Sgt, Co K, 29<sup>th</sup> Ala. Widow Martha J Powell, Ariton, Dale County. She was born 8 Dec 1839 at Clayton in Barbour County. On pension roll of Pike County. Signed her x mark 22 Apr 1915, age 75. Married Larkin W Powell 23 Nov 1858. Mrs A V Johnson attested to her state as widow on 15 Jan 1916. L W Powell's PO on 13 Jan 1897 was Tarentum, Alabama (Pike Co). He died 5 Dec 1898. (Son of George and Bersheba of Barbour County.)

**Levie Kenyon Powell**, Co A, 57<sup>th</sup> Ala. Pike Co. Did not take notes. Appl lists children 13 Sep 1923.

**N B Powell**, 2<sup>nd</sup> Lt Co B, 18<sup>th</sup> Ala. Covington County. Widow **May (sic) S Powell**. He died 27 Dec 1917. She was born near Georgianna in Butler Co; father was **Joe Brooks**, died abt 1870 near Georgianna. Married N B Powell in Aug 1911 (another app says 3 Aug 1913) at Opp, Al.. Married first husband Yancy Ludlow in 1885 (another app says Y A Ledlow, 1886 at Georgianna). He died 26 Dec 1901. Her full name: Mary Ann Martha R Sular Powell. (Napoleon B Powell, age 61, and wife Lucretia, 62, on 1900 census Covington Co., indexed as Wafolian B.)

Pension of Mrs N B Powell, Covington County. She died 29 July 1947. No other information.

**S W Powell**, Co I, 40<sup>th</sup> Ala. Mrs. **Mary J Powell**, on pension roll (old #7869) of Covington County, age 81, signed her x mark to age affidavit 11 Sep 1908. He died Feb 1863. T D Coon (his x mark) and H M Coon (signature) attested to service of S W Powell on 11 Apr 1899. (Same as Samuel R Powell?)

Samuel Powell, Co C, 37<sup>th</sup> Ala, Coffee County. Little info. Possibly same as Samuel R Powell?

**Samuel R Powell**, Co I, 40<sup>th</sup> Ala, Covington County. Widow Mrs M J (Coon) Powell. Note on folder: *Please note - all the records in this envelope are for Mary Jane Powell except one which is for Margaret L Powell.*Mary Jane Powell was 86 ½ years old in 1916 and Margaret L Powell was 103 in 1908. (In folder was affidavit for Margaret L Powell on 10 Apr 1908 that she was 103 years old.)

Samuel R Powell died of disease during the war. Mary Jane Powell's PO address on 15 Apr 1896 was Green Bay. Signed her x mark. On 26 May 1897 her PO was Sanford. On 29 Apr 1915, her PO address was Opp, Rt #1. She was born 18 Jul 1829 in Jackson County, Georgia, being 85 yrs old at time of app. On pension roll of Covington Co (#29587). New pension #1929.

Some apps for widow of Samuel R Powell as Jane Powell (her x mark).

3 Jan 1916: request to place her name on first class pension roll. Current pension #7686 of Covington County. Husband's name was **Samuel Richard? Powell** (middle name probably Richard, but very sloppy and hard to decipher), married 6 Jan 1859. Age 86 and 6 months. Wit: C W Morgan? and **W D Powell**. **T D Coon** (his x mark) attested to her state as widow. (On same day, 3 Jan 1916, Mary Powell Coon, widow of H M Coon, signed similar application to be placed on second class pension roll, with same witnesses. They must have all gone down to the legal office together.) On 20 May 1918, her PO address was Sanford. May 1894 app says he was in 37<sup>th</sup> Reg't.

**W L Powell**, Coffee County. Pvt Co A, 33rd Al Inf. Enlisted 10 Mar 186? near Greenville. Honorably discharged 15 May 1865. Unable to make a living on account of general disability. PO Leverett, Coffee County. Signed his x mark, sworn before JP on 6 Jun 1903. Confederate service attested to by James L Larkins and P J Ham on same date. Property inventory showed no real or personal property. No further information. (William Leonard)

**William J Powell**, Co H, 21<sup>st</sup> Ala, Pike County, died Mar 1893. Widow Eliza J Powell. No real property. Signed Eliza P Powell, 25 Apr 1899. G W Grantham and Thomas J Green attested to his service on 1 May 1899. On app of 1 May 1915, she stated she was widow of Joe (W added in front) Powell, that she was born in Alabama (no place given) in Apr 1841, being 74, on pension roll of Pike, #20841. Note on form: "This old lady has cancer of the eyes and is just about blind. Her left eye is eated (sic) out by the cancer." Signature is by S A Powell. (Son of George C and Orphie.)

Pg 304: In list of casualties in Co I, 15<sup>th</sup> Al Regt from 6-10 May 1864, mentions **Wilson Powell**, missing in action.

Pg 305: In letter from a soldier in camp near Spotsylvania CH, Va, 15 May 1864, referring to action by Law's Brigade, mentions that **William Powell** was killed. Says that on the 9<sup>th</sup>, **G E Powell** was killed by a sharpshooter. Same letter mentions that **Wilson Powell** was taken prisoner on the 5<sup>th</sup>.

Pg 301: In a letter to the editor, refers to an incident in Union Springs. Among soldiers named were **Berry Owens**, **William Powell** and **H E Powell**.

Pg 139: In a letter from a soldier in the Quitman Guards, 15<sup>th</sup> Al Reg't, camp near Port Royal, Va, 17 Dec 1862, mentions that **J E Powell** was slightly wounded in the leg and hand.

On 10 May 1862, 55 of the 106 members reenlisted in Co I, 40<sup>th</sup> Al Inf Reg't for the duration of the war. The remainder returned home, but many were later forced into service.
