Owens, W H 15, 23 & 25-13-27 and 30-13--28. **Whitman Hill Owens**, b. ca 1794 NC, to Al from Ga after 1839, d. 1870 Henry Co, Al, son of William Owens who died 1839 Decatur Co, Ga ("Henry's Heritage", p 64, by Warren). Eliza Ann Hare (1st wife), b 12 Nov 1795 Sumpter Dist, SC, d 9 Nov 1854, buried Glennville Cem, Russell Co, Al, dau of Edmon Hare and Mary Scott (ibid). Nancy A, (2nd wife), b. ca 1810 Ga (1860 census).

Owens, W J. 29-13-26 (Bullock). William J Owens, b. ca 1810 Ga, d. by 5 Feb 1859 (OR 9, p 864/7), lived at Midway, Al. Elizabeth A (wife), b. ca 1815 Ga - she may have been his second wife.

Powell, Dan'l. 11-8-23. There is no **Daniel Powell** in the early records. There is a **David Powell**, b. ca 1801 SC, d. by July 1854 (OR 6,p102). He married Mrs Eady Lewis 7 Feb 1847, b. ca 1806 Ga - his second wife.

Powell, Geo. 10&15-10-26. **George Powell**, b. ca 1802 SC. In April 1840, the commissioners of Barbour Co deeded the above land to George Powell by order of the court of Dale Co, Ala - the land had been sold to George Powell in Mar 1836 by **Abner Powell** "in his lifetime" (CR B, p851). **Bersheba** (wife), b. ca 1805 SC.

Powell, J S. 11, 12 & 13-13-28 (Russell Co). **Joseph S Powell** bought a lot in Glennville in Jan 1853 (CR K, p284) - no further record. **Antoinetta A C Stovall** (wife - m. 7 Dec 1847, probably in Milledgeville, Ga), dau of Joseph Stovall of Milledgeville, Ga ("Southern Christian Advocate", 24 Dec 1847).

Powell, Ransom. 11-8-23. **Ransom Powell**, b. ca 1825 SC, heir of **David Powell** who died by July 1854, at which time Ransom Powell was of Dale Co, Al (OR 6, p232/3). Sarah C (wife?), b. ca 1822 SC.

pg 92:

Nancy, S. 7-8-24. **Sylvester Nance**, b. ca 1825 SC. **Catherine** (1st wife), b. ca 1823 SC. She was an heir of **David Powell** who died by Sep 1854 (OR 6, p 232/3). Martha (2nd wife), b. ca 1836 Al. (1880 Census).

pg 114:

Stokes, Joel D. 26-8-24. **Joel D Stokes**, b. ca 1831 Al, d. by Dec 1862 (OR 12, p643), son or Irwin J Stokes (b. ca 1805 SC) with whom he was living in 1850 and 1860. Elizabeth Ketchem (probably 1st wife - m. 8 Apr 1855). **Matilda J Powell** (2nd wife - m 22 Jul 1860), b. ca 1843 Al (1860 census). In 1860, she was in the household of **William Stokes**, b. ca 1832 Al. In 1850, William Stokes was in the household of Irwin J Stokes and Matilda Powell was in the household of David Powell (b. ca 1801 SC).

pg 58:

Hopkins, J. 11-10-26. Andrew Jackson Hopkins, b. ca 1827 SC. **Rachel M Powell** (wife - m 30 Jul 1848), b. ca 1829 Ga, possibly dau of **George and Bashaba Powell** (CR J, p200).

pg 119:

Thorn, N. 11 & 12-8-23. Nicholas Thorn, b. ca 1790 SC, to Ga by 1836, in Al by 1850. Martha (wife - CR L, p296), b. ca 1802 SC. In 1870, she was living with her dau, Matilda, who had married **Joseph Powell** 2 Jan 1853.

Pg 196 refers to C B Powell as one of the four men ordained to the ministry by Mount Pleasant Church, located on Hwy 27 about four miles south of Enterprise, and constituted either in 1873 or 1874.
P264 refers to C B Powell as one of the early pastors of Victoria Baptist Church, "located about twelve miles north of Elba on state hwy 125, the Elba-Brundidge Road. Up to 1967, it was known as Bethlehem."

Company originally formed 2 Apr 1862 for 90 days service to state of Alabama, called itself "Covington County Farmers." By 15 Apr 1862, company had been moved to Mobile and awaited orders. On 10 May 1862, 55 of the 106 members reenlisted in Co I, 40th Al Inf Reg't for the duration of the war. The remainder returned home, but many were later forced into service.
