1. ALICE C¹ POWELL¹ was born 16 Feb 1828 in Georgia^{2,3}, and died 21 Jan 1914³. She married KINEON E WHITE 22 May 1850 in Troy, Pike County, Alabama^{4,5}. He was born Bet. 1829 - 1831 in Alabama^{6,7,8}, and died 12 Oct 1881 in Mary Esther, Santa Rosa County, Florida⁹.

Notes for ALICE C POWELL:

Possible but NOT PROVEN that she is dau of Daniel and Sarah Powell. She went to West Florida about the same time they did and in 1860 was adjacent George and Daniel Powell who appear to be sons of Daniel. Daniel had a female in his household in 1840 the right age for Alice. She had a nephew, Asa M Powell, who appears to be son of Jacob M who may also be a son of Daniel's, but *that is not proven*, *either*.

Her birthplace is uncertain. Three census records have her b. Ga: 1860, 1880 and 1910, but 1850 has SC, 1870 has Al and 1900 has Fl.

25 Nov 2006: I spoke on the phone with Mary (last name unknown), a granddaughter of John W (Judge) White (b. abt 1865), son of Alice Powell White. I was referred to her by Doris Buffum of W Fl Gen Soc and Butler Co Rootsweb mailing list. Mary is no longer an active researcher. She had not identified any of Alice's family. Her mother had told Mary that she had uncles Tiney and Toby, John White's daughter Minnie married Travis Powell, and Alice's daughter Emma married Ephraim Neil in Santa Rosa Co, 17 Apr 1877. (I have not identified Toby. Travis Powell was from Mobile County, Alabama, and his father and grandfather were born in Mississippi. I have not found any connection between them and the SE Alabama Powells.)

W J Kimmons and R W Cagle attested to her state as widow of K E White on 27 Oct 1902. Note written on doctor's statement area of form: "We were about sixty miles from a physician and as he was in the bed only about 9 days we did not have a Doctor at time of death October 12th 1881." Alice C White (her x mark)

File includes a handwritten letter in pencil, on paper stamped with "Office of D G McLeod, County Judge, Walton County, Florida, dated 9 Sep 1902, to W J Kimmons of Bluff Springs, Fl. Letter refers to "our old comrade Corporal Kin White" and deals with procedures of filling out statement forms and contains list of remaining members of Co H. File also contains a handwritten note in pencil: "Oct the 10 1902. My Father Kinion White died October the 12, 1881." Signed Mrs E A Neal. Also contains note from W J Kimmons of Bluff Springs stating that "Mr K E White and Miss Alice C Powell were married May 22 (no year specified) at Troy, Alabama (Pike County)."
