1. ALLEN¹ POWELL was born Feb 1866 in Alabama¹, and died Aft. Apr 1910². He married CLEO A HAYNES³ 26 Dec 1890 in Barbour County, Alabama⁴. She was born Abt. 1874 in Alabama⁵, and died Aft. Apr 1910⁶.

Notes for ALLEN POWELL:
Not fnd 1870-80 or 1920-30.

An unidentified Henry Powell (b. c1843) in Dale Co, PO Newton, 1870, had a son Alen, age 1.

Also in Precinct 8, Grant, pg 107A, #66/66: Ben L Powell, 63 (son of Abraham, b. 1805-10 SC, and Lithie), and son Wm BF & family. Also there in 1900 (at pg 109B, #111/112) was Charlie B Powell and his father Perry D (son of Abraham and Lithie) and his brothers Angus and Madison.

There is a Mary Haynes, 33, Al, in Barbour Co, Atkinsons' Pct, 1880, pg 330C, with dau Anna, age 7, son Robt A, age 5. **Lecie (Litha) Powell, widow of Abraham**, was also in Atkinson's Pct in Barbour 1880, pg 342C, adjacent sons Perry D and Ben L. They all moved to Grant's Pct in Coffee Co by 1900. Robert A Haynes (age illegible) and wife Minnie (19) were also in Grant's Pct, pg 105A, on 4 June. They were also enumerated in Elba on 19 June (ages 25 and 19).

Joseph, presumed son of David Powell, did not have any children listed with him in 1870. Abraham and Lithie did not have any children his age in 1870 or 1880. So who does Allen belong to that keeps him close to Abraham's family? Henry Powell in Dale Co had a son Allen, age 1 in 1870.

At #79/80 in Grant's Beat: Ervin Powell, 28, son of Pony (Albert?).
