Notes for JACOB M POWELL:

This family structure is VERY SPECULATIVE.

NOT PROVEN that any of these children actually belong to Jacob, but Zilpha and Asa M closely fit the children listed by initial only on 1860 census. We know that Asa and Zilpha are siblings because Asa's son Mack was nephew in Zilpha's household in 1900. We guess that Zilpha and Cynthia are sisters because Zilpha was in Cynthia's household in 1870. Mary was sister-in-law in Zilpha's household in 1880.

Possibly same people? Second marriage?

There is also a Mary Powell who does not fit, age 20-30. She may be Mary Beckworth Powell, wife of Cornelius, three entries away from A (prob Amos) Beckworth. There is a J N and a J W Powell who do not fit Jacob.

### Notes for MARY POWELL:

Mary is a puzzle. Her age was listed as 20 in 1880, but she was not on the 1860 census of Jacob M's family. Her birthdate of Feb 1865 on the 1900 census seems too far off, and she was 47 on the 1910 census. If she had been born in 1865, that would mean a 24 year span between her and Ann, the oldest known child of Jacob and Mary, and a 10-year gap between her and C A, the next youngest known child, age 5 in 1860, unless there were others we don't know about (always possible). A compromise birth year of about 1861-63 seems more reasonable. Even at that, it leaves a 6-8-year gap between her and C A. It is always possible that she could be the child of Ann, who was 18 in 1860. Where was she in 1870? Not listed with Zilpha in Cynthia's household. No likely Powells in Conecuh Co. No likely Mary/Mollie found in Conecuh, Butler or Monroe County.

NAME UNCERTAIN! Listed as Jane, age 2, in 1850. Cynthia Powell Durden was age 20 on 1870 Conecuh census, 2 years older than sister Zilpha. Unknown if T B is same as Jane or if Jane is same as Cynthia.
