Census records of 1880-85 indicate this James Riley to be born c1845-46; 1910 says c1842; 1900 says Apr 1844. Coleman had a son Riley, b. c1842, in 1850 Pike Co. Benjamin and Matilda Powell also had a son Riley J, b. c1843, in 1860 Dale Co, Alabama, but he appears to be Jordan from 1850 (Riley Jordan).

Not found (or identified) in 1860-70. Coleman's family not found in 1860-70, either.

"No 15992. State of Florida. Santa Rosa County.

Personally came before me J R Powell, who being sworn, says that he is the same J R Powell of Co E, 42 Al Inf - who was captured at Vicksburg, Mississippi, and paroled 4 Jul 1863, and exchanged at Demopolis, Al, on or about the latter part of Oct 1863, when he immediately entered into the Mississippi campaign in the Western army and served till the close of the war, or until after the battle of Bentonville, NC, from which place he was marched back to Greensbourgh (sic), NC, where he stacked arms. He further states that he was the only J R Powell in Co E, 42 Al Inf, but that he afterwards found another J R Powell in the city of Pensacola who had applied for a pension but was not drawing because of a lack of two years of age. That J R Powell is now dead, but his widow is a pensioner. Signed J R Powell (his x mark). Sworn to and subscribed before me this 16th day of Nov AD 1909, J T Mapoles, Justice of the Peace."

MRS. ST. MARY DEAD

Mrs. Joseph St. Mary died at the family residence in Bagdad Wednesday night at 9:30 o'clock after having been ill for several days. While her death was not wholly unlooked for by those who had been apprised of her serious illness, yet it was quite a shock to her many friends and acquaintances. Mrs. St. Mary was about 75 years of age and had resided in Santa Rosa county all of her life. Before her marriage, she was Miss Elizabeth Lewis. She was married first to Benjamin Land, who died about eight months after their marriage. About the close of the Civil War, she was married to Joseph St. Mary, then only a few years from Portugal, who survives her. They settled near Blackwater Bay and have lived a quiet life, forming many warm friendships among a large circle of people who knew them. To them were born six children, five of whom are still living. They are Frank St. Mary, Mrs. Pauline Lewis, Mrs. Josephine Lewis, Joseph St. Mary Jr., all of **Bagdad, Fla.**, and Mrs. Dell Kimmons of Tuscaloosa, Ala. One daughter, **Mrs. Rosa Powell** died seven years ago leaving two young children who have resided with their grandparents.)
