Here's what I have for John Randolph Powell:

He was born September 24, 1854, the son of John Powell and Minnie -(?). He married Nancy Alice Vaughn (b. Jan. 4, 1862, AL), the daughter of Asa Oliver Vaughn and Sarah Amanda Fowler at the Vaughn home in Barbour County, AL. The wedding was performed by Rev. W. H. Paterson.

(Nancy Alice Vaughn was received by experience into fellowship at **Ramah Church, Barbour County, AL** on August 25, 1874)

John and Nancy Alice Powell were dismissed by letter from Ramah Church on February 22, 1889.

He died June 14, 1893, at Montgomery, Montgomery Co., AL. Nancy Alice Vaughn Powell died October 15, either in 1903 or 1905 .
