In 1880, John C McDougald lived in the Marl/Samson area adjacent James J and Malinda Gilmore. John C's dau Ruth married Jesse Cowan, son of Polly Ann Gray and Samuel Cowan. Four entries away from the McDougalds was the family of John T Martin, Sr, his wife, Elizabeth, and 2 stepchildren, **Dora (18)** and **Thomas M (15) Warren**. This same family was enumerated in TWP 1 in 1870 adjacent Joseph Commander and Columbus Yarbrough, near Matthew McAlily, Amos Ausley, Wm McDuffie and Daniel Vaughan, who had Quitman Summerlin in his household.

Many of these same neighbors are together in 1870 and 1880 Precinct 4 (Limestone in 1900), indicating that this 1870 listing is also in Limestone. Eucheeanna may have been the nearest PO at the time. Limestone is in the extreme NE of Walton, almost on the county lines of Holmes and Geneva. Did Limestone become Darlington? According to a listing of Limestone Community Cemetery at <http://ftp.rootsweb.com/pub/usgenweb/fl/walton/cemetery/limestone.txt> by Tonia Porter, the cemetery is located between the communities of Gaskin and Darlington in North Walton County. Eucheeanna is a few miles SW of Ponce de Leon in Holmes County, Florida.
